THE NPDES ERULE

What is the NPDES Electronic Reporting eRule?





MANDATES ELECTRONIC REPORTS FOR:

- Discharge Monitoring Reports (DMRs),
- General Permit Reports, (notice of intent to discharge),
- Other specified program reports (like Industrial Pretreatment)



- Phase 1 Implementation deadline: Dec 21, 2016
 - Included DMRs and Federal Biosolids Annual Report



- Phase 1 Implementation deadline: Dec 21, 2016
 - Included DMRs and Federal Biosolids Annual Report

- Phase 2 Implementation deadline: Originally Dec 21, 2020
 - Includes Pretreatment Program Annual Reports



Good news!

- In Sep 2020, EPA passed a 5 year extension
- New Phase 2 Implementation deadline: **Dec 21 2025**

WHAT DATA YOU COLLECT

- EPA published a technical document on required data elements
- Delegated States may change their requirements to match EPA
- Delegated states will likely require more data elements then EPA

- New data elements might mean collecting more data...
- Change in paper reports/forms?
- Change in excel files?
- Change in database or software?
- Change in processes?

HOW YOU REPORT IPP DATA

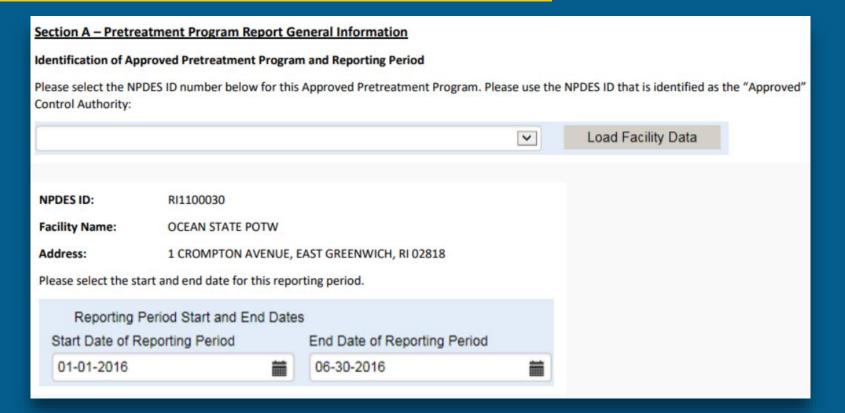
- All electronic!
- IPP's with EPA as Control Authority, will use EPA's "NPDES Electronic Reporting Tool (NeT)"
- IPP's in some states with Control Authority will also be using NeT
- Others will report using their states systems (like South Dakota's SDDENR)

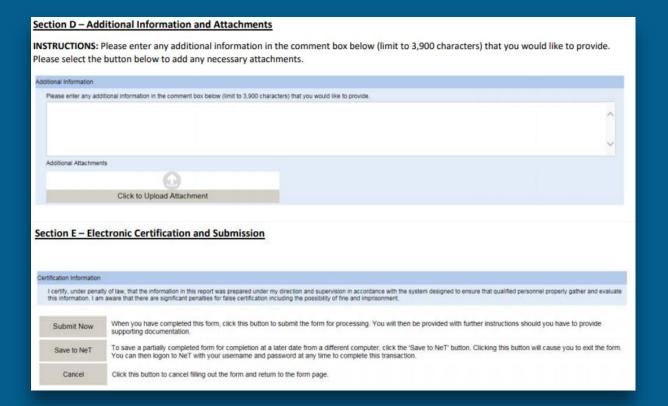

- How much time do I need to get ready for this?
- Do I have the right system or software in place to generate this report electronically?



Collecting the right data?

- Read EPA's Technical Paper #7
- Ask your Control Authority Rep!



How much time to prepare?

- Deadline Dec 2025.
 - o All 2025 IPP data will be submitted electronically
- Start preparing now!
- Give yourself at least 1 entire Pretreatment year



Are my systems ready for this?

- How easy is it to get my data together?
- Will I have to type data into NeT?
- What other software is available to help me?
